- manage the basic methods of cleaning and conserving of paintings and wall paintings;
- justify the selected art solution, including used methods;
- select suitable techniques, technological procedures and the corresponding materials on the basis of an analysis of the
- use graphic programs for processing graphic designs and their implementation.

The graduate is employed in the field of colour interior design solutions, implementation of the paintings in architecture, publicity and scenic paintings, carrying out simple restoration work aimed at cleaning and conserving interior paintings. He or she can also find work in independent design activities.

He/she can be part of implementation and creative teams and workshops engaged in relevant areas of applied art, or he/she can perform design activities on his/her own.
